Participants may also share their Magic Item on social media channels with the hashtag #WhatsInTheBag and tag @DnDBeyond, the official <u>D&D Discord</u> channel for this contest (#whats-in-the-bag), or the official dndbeyond.com forum thread for the Promotion; however, note that sharing on social media, Discord, or forums <u>does not</u> earn additional entries.

- 2. **Submission Requirements:** Each Participant may submit only one (1) entry. Submissions must include:
 - A name for your Magic Item;
 - A 1- to 3-sentence description (max of 50 words) in English; and
 - One (1) simple mechanic or effect.

No need to build full mechanics, stats, or modifiers. No need for it to be functional within the D&D Beyond Character Sheet. Simplicity is part of the fun.

- 3. **Rules and Limitations:** To qualify, you must abide by the following:
 - You must use the D&D Beyond Homebrew Magic Item tool
 - You must use the Homebrew item tag 'BagOfHolding2025'
 - The submission must be your own original work (no AI-generated content!)
 - You may not use or reproduce Netflix characters, references, or likenesses
 - You may not include any third-party IP
 - You may not include any content, characters, likenesses or references from any TV show (including, without limitation the Stranger Things series), film, or other creative material.
 - You must reside in eligible countries: USA, Canada, UK, Germany, France

- 8. **Participant Responsibility:** Participants are responsible for creating and sharing their own submissions and verifying receipt of those submissions if needed. Incomplete submissions will not qualify.
