

DNDBEYOND “THE REALMS WILL KNOW YOUR NAME” HOMEBREW CONTEST RULES:

This Forgotten Realms: Adventures in Faerûn and Forgotten Realms: Heroes of Faerûn homebrew contest (the “**Promotion**”) is governed by the following rules. By participating in the Promotion, you agree to be bound by Wizards of the Coast LLC's (“**Wizards**”) [General Terms](#) (“**General Terms**”), the [D&D Beyond Terms of Service](#) (“**DDB Terms**”), [Discord Terms of Service](#) (“**Discord Terms**”) if posting content to Discord, and the [Wizards Code of Conduct](#) (“**Code of Conduct**”).

Entries are subject to verification of eligibility and compliance with these and other applicable terms.

THIS PROMOTION IS OPEN TO RESIDENTS OF THE UNITED STATES, CANADA, THE UNITED KINGDOM, GERMANY, AND FRANCE. All submissions received from Participants located in any other geographic region will be automatically disqualified.

1. **Promotion and Eligibility:** To be eligible, a participant (“**you**” or “**Participant**”) must create one (1) published homebrew feat (“**Feat**”) using the Homebrew tool on D&D Beyond at <https://www.dndbeyond.com/homebrew> and using the Homebrew Feat tag ‘RealmsFeat2025’ within the “Basic Information” section for the Description of your Feat.
 2. **Submission Requirements:** Each Participant may submit only one (1) entry. Submissions must include:
 - A name for your Feat;
 - A 1- to 3-sentence Description (max of 125 words) in English in the “Basic Information” section of your Feat; and
 - One (1) simple mechanic or effect
 - No need to build to build full mechanics, stats, or modifiers. No need for it to be functional within the D&D Beyond Character Sheet. Simplicity is part of the fun.
 3. **Rules and Limitations:** To qualify, you must abide by the following:
 - You must use the D&D Beyond Homebrew Feat tool
 - You must use the Homebrew Feat tag ‘RealmsFeat2025’
 - The submission must be your own original work (no AI-generated content!)
 - You may not include any third-party IP
 - You must reside in eligible countries: **USA, Canada, UK, Germany, France**
 4. **Rewards:** The three winning participants who submit the feat in accordance with the submission requirements above will be eligible to receive:
 - One (1) custom D&D sports jersey with the winner's choice of name customization and jersey number
 - One (1) Forgotten Realms Ultimate Bundle
- Rewards are subject to availability and the terms and conditions of this Promotion. A total of three (3) winners will be selected from eligible submissions.
5. **Promotion Period:** This Promotion begins at **10:00 am Pacific Time on November 11, 2025** and ends at **10:00 am Pacific Time on November 18, 2025**. Submissions received after this time will not be eligible for rewards.
 6. **Reward Limitation:** There is a limit of one reward per Participant. Multiple submissions from the same Participant will not be eligible for additional rewards. If a Participant submits more than one entry,

only the most recent entry will be judged.

7. **Judging Criteria:** Submissions will be reviewed by members of the D&D Team and the D&D Community Team, and all judging is final. The criteria for judging are:
 - *Legendary Flavor:* Does the feat feel like it belongs to a hero whose name the Realms would remember? Is it bold, thematic, and evocative?
 - *Creativity and Originality:* Does the submission introduce a fresh idea, clever mechanic, or unexpected twist that stands out from standard options?
 - *Playfulness and Personality:* Does the feat reflect the spirit of the contest, with a tone that is fun, memorable, and unmistakably personal?
 - *Adherence to Contest Rules:* Does your submission meet all of the listed requirements?
8. **Participant Responsibility:** Participants are responsible for creating and sharing their own submissions and verifying receipt of those submissions if needed. Incomplete submissions will not qualify.
9. **Termination; Disqualifications.** Wizards reserves the right to modify, revise, cancel or terminate the Promotion or any portion thereof at its sole discretion and without liability to you. Further, Wizards, at its sole discretion, may disqualify you for violations of the Code of Conduct including, without limitation, unsportsmanlike behavior, collusion, cheating, infringement, or toxic behavior.
10. **Limitation of Liability.** To the extent permitted by applicable law, Participants agrees to release, discharge, hold harmless and indemnify Wizards, its parent, affiliates, subsidiaries and advertising and Promotion agencies and all of their respective officers, directors, shareholders, employees, agents and representatives of the forgoing (collectively, "**Wizards Entities**") from any and all liability, losses and damages of any kind (including, without limitation, arising from claims based upon copyright infringement, trademark infringement, invasion of privacy, defamation, or right of publicity) to persons or property resulting, in whole or in part, directly or indirectly, from Participant's participation in the Promotion and/or the acceptance or use of any Reward. Wizards Entities are not responsible for any unanticipated failures or difficulties; or for any other errors of any kind, whether human, mechanical, or electronic.
11. **Choice of Law.** To the extent permitted by law, any and all legal actions or claims arising in connection with this Promotion must be brought in a court of competent jurisdiction in King County, Washington, U.S.A. To the extent permitted by law, Washington law, without reference to Washington choice of law rules, governs this Promotion and all aspects related thereto.

Except where prohibited, each Participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, and in no event will a Participant be entitled to obtain attorneys' fees or other legal costs; (3) no punitive, incidental, special, consequential or other damages, including without limitation lost profits may be awarded (collectively, "**Special Damages**"); and (4) Participant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.

12. **General Conditions.** This Promotion is subject to all applicable federal, provincial, state and local laws. These Terms and Conditions may be translated into other languages. In the event of any conflict or inconsistency between any translated version of these Terms and Conditions and the English version of these rules, the English version shall prevail, govern and control. Participation in this Promotion does not constitute entry into any other promotion, tournament, competition, contest or sweepstakes conducted by Wizards.
